##### CFJL Timeline Review

Currently the Taskforce's timeline is split into 4 main categories focusing on different elements of the final implementation plan, which includes:

**Phase 1:** Launch Taskforce, Review Data and Define System Changes (March-22)

**Phase 2:** Map Ideal System and Develop Countywide Plan (September-22)

**Phase 3:** Develop Agency/ Department Plans (March-23)

**Phase 4:** Deliver Final Implementation Plans (April-24)

##### CFJL Interview Updates

RDA is currently conducting interviews to learn more about each members' perspective regarding their goals for the taskforce. This way RDA will have an idea on what the members' expectations are moving forward.

##### Sequential Intercept Model (SIM) Overview

The SIM model provides a framework for thinking about where people come into contact with the system and where they can be diverted to services. Each department will have a different role in each of the intercepts. Now, the task of the Taskforce is to ensure that the use of the model is imbedded into the system.

Following the new expanded sequential intercept model, there are an additional two intercepts present. Intercept -2 and Intercept -1 are extensions of Intercept 0 which focuses on Hospital, Crisis Respite, Peer & Community Services.

According to the JIMHT Recommendations Roadmap to Implementation the following are the Tier 1 prioritized recommendations: Greatly expand affordable housing & supportive living, Expand youth prevention & TAY services, Expand conflict mediation & violence prevention programs, Expand non-law enforcement involved crisis response, Expand acute care county-wide, Design Forensic diversion, & reentry services system of care, and continue to integrate innovative rehabilitative programs in community supervision.

#### JIMH Report Summary

As of July 2020, ACBH requested JIMHT to develop formal recommendations to reduce the number of persons with mental illness in jail. With over 200 people involved in the JIMHT community engagement process from July 2020 - October 2020, they presented 72 formal recommendations including 17 priorities and reviewed 5 specific goals that CFJL looked at.

#### Discussion & Questions

Member Dixon expressed her concern about Intercept 5, placing more probation officers in the jail. She mentioned that a better solution would be to place more service workers (i.e. social workers, mental health specialist).

Member Lee posed a question regarding the individuals who are no longer on probation or on AB 1950 (early dismissal) whether they would fall back to Intercept 5 or revert to a different intercept point? Facilitator Freedman replied that each case will be determined on a case-by-case basis knowing that each case is unique on its own.

Member Dashiell urged that families of the SMI should be a priority of the Task Force as a preventative measure. Member Louis seconds this comment and in addition adds that educating/equipping the families with resources to help their family members remain out of the jail system should be a priority.

Member Bedrossian expressed her concern about the direction of the task force indicating that the focus seems to be focused on the system reform rather than on the SMI who are the intended target. She also requests the board to provide clarity on what work has already been done by JIMHT versus what needs the Task Forces' input.
