### **CFJL Approved Taskforce Departmental Plan Approach**

The Taskforce will focus by intercept and department to make recommendations for each Department/Agency. Updates provided by each department for their plan for each intercept. Looking to see opinions on this approach.

In Option 4, the Taskforce will have the opportunity to consider the fiscal implications of various elements of the plans and to provide recommendations to input to the development of those plans.

The goal of the two subcommittees would be to identify what information should be brought to the task force in coordination with RDA, who would support that effort, by identifying other models or other data sources that should be brought for the considerations of the intercepts within the total system.

Member Dashiell would like to make sure that data becomes part of the consideration to ensure that the Taskforce has a firm understanding of who is impacted.

## **Deep-Dive Departmental Plan & Meeting Prioritization**

Prioritization Input as discussed:

- Demographic data on incarcerations and 51/50s
- JIMH racial equity goals
- CFJL presentations from other jurisdictions
- Deep Dive into Sequential Intercept Map (SIM)
- JIMH Recommendations Review

It would be helpful to take a look at county jail mental health services (AFBH). May be appropriate to look into the field evaluation criteria for determining whether or not individuals should be 51/50 or sent to jail to receive services internally. May need to propose intensive law enforcement training for officers in the exercise of discretion.

Member Dasheill comments on the lack of diverse resources available to those of the African American community.

There is a need to look at the intercepts and the data to make sure that there aren't any particular structural issues that are interfering with quality services to the underrepresented communities within the county. There is a significant need for specialized services for those within the African American community.

It would be beneficial to include family input into the determination of 51/50 status for their loved ones at the public defense level. Receiving honest data on why the African American populations are criminalized more than other ethnic groups would help give insight into what the task force can do to reduce recidivism within this community.
